As Governor of Queensland and Patron of Childhood Cancer Support Inc, I wish to express my great pride in what this organisation has achieved over the past year and my heartfelt thanks to all those who made it possible.

Childhood Cancer Support has indeed had a remarkable year supporting families impacted by this indiscriminate disease. Among its deeply kind and profoundly helpful services to the families of those receiving treatment at the Queensland Children's Hospital were the provision of long-term housing for 51 regional families and short-term accommodation for 103 families in nearby Woolloongabba. Additionally, a complimentary patient transport service, upgraded with a \$100,000 grant, provided families with a welcome reprieve from significant hospital parking fees.

Another milestone achieved in the 2023 financial year was development approval for 15 units in East Brisbane that will serve as a second home to families going through one of the toughest and most uncertain times in their lives.

Other notable accomplishments included the successful revival of the Camp Crystal event after a three-year hiatus, offering much-needed respite for pediatric oncology families, with an outing to the EKKA providing a light-hearted boost.

The organisation achieved much-deserved recognition at the Fundraising Institute of Australia 2023 National Awards, and despite a challenging climate, the fundraising team secured \$606,299, an 18% increase on the previous year. Third-party fundraisers also contributed, through events such as Ride for Love and the Long Lunch.

My gratitude extends to the many volunteers and charities that assist with everything from care packs and music therapy to toys and entertainment. You truly do make the world that much brighter, and cancer treatment that much more bearable.

On behalf of all Queenslanders, thank you for your continued efforts, your selflessness and your strength of purpose.

PROPOSED EAST BRISBANE DEVELOPMENT



GENERAL MANAGER'S REPORT

It is with pleasure that I provide this annual review for Childhood Cancer Support for the 2023 financial year.

With the easing of restrictions around the COVID-19 pandemic we were able to return to some "normalcy" here at Childhood Cancer Support. Our organisation, alongside families, communities and businesses have endured many challenges around the pandemic and everyone is to be commended on staying the course to get through this difficult time.

In April 2023, we were so pleased to be able to provide a Camp Crystal event for our paediatric oncology families in the beautiful Queensland hinterland of Mt Tamborine. This event was a huge success and, after 3 years of not being able to provide a camp for our families, the event was well received. It was so great to see everyone and the happy, smiling faces of families enjoying some respite time.

Camp Crystal 2023 would not have been possible without the generous grant funding of Newman's Own Foundation to make this happen. We cannot thank them enough. And the good news is that Newman's Own Foundation has again provided funding so we can provide another Camp Crystal for our families in 2024.

Our accommodation provided long-term housing for 51 regional families (196 family members) from throughout Queensland and Northern NSW during this past financial year providing a home in Brisbane during their child's cancer treatment.

Our short-term accommodation house at Woolloongabba provided 103 families with accommodation (265 family members) during the year. Our short-term rooms accommodate regional families returning to Brisbane for short stay medical check-ups at the Queensland Children's Hospital and is located

800 metres from the hospital for the convenience of families.

Our complimentary Patient Transport Service continued to transport families to and from the Queensland Children's Hospital from our accommodation facilities and provided airport transfer services for families to and from Brisbane Airport when their children required oncology medical treatments or appointments. 1,683 passengers were provided this complimentary patient transport service during this financial year saving families thousands of dollars in hospital car parking fees.

I am pleased to advise that we were able to upgrade our complimentary Patient Transport Service vehicle during the year with the generous funding of \$100,000 from the Gambling Community Benefit Fund (GCBF). A new 12-seater Toyota Hiace Commuter vehicle fitted with a wheelchair lift, was delivered to us in October 2022. In addition, we were also able to upgrade our second general purpose vehicle to an MG SUV allowing for a safer and larger vehicle to travel throughout Queensland to regional centres. Our sincere thanks to GCBF for continuously supporting Childhood Cancer Support in our support of families impacted by childhood cancer. Their support is extraordinary.

Our accommodation and support services team member, Trish Smyth, has again gone over and above in supporting our families during their stay with us, and ensuring they have suitable accommodation at our facilities and providing them with everything they need to get them through this difficult time.

Despite the past 3 years being so challenging, our fundraising team member, Pat Hooper, continues to increase our fundraising income through our in-house events and supporting community fundraisers. A total of \$606,299 was raised in fundraising this past financial year (an increase of 18% from the 2022 financial year).

Our Grants Program was again successful this year with \$361,783 received from grant funders in this past financial year. These funds have enabled us to provide significant property maintenance and renovations around our houses as well as offer a Music Therapy Program, Chemotherapy and Care Packs, camp for our families, new vehicles, new children's car seats for our vehicles and home safety accessories for our units, nursery and toddler furniture equipment, funding and Christmas presents for our annual Family Christmas Party.

We are very proud to advise that our "Feels Like Home" Grants Program was recognised nationally at the Fundraising Institute of Australia Fundraising Awards in February 2023 at the Melbourne Convention Centre. Childhood Cancer Support was awarded the National Award for the best fundraising project in the "Impact on a Shoestring" category, and then we went on to win the overall National Award for the "Most Outstanding Fundraising Project". These awards are judged by expert fundraisers in the charitable sector so we were very honoured to be recognised by our esteem peers in the sector. We are indeed very proud, and this honour solidifies our organisation as being recognised for doing amazing work in the charity space in Queensland for the past 48 years.

A special thank you to our team of wonderful housekeeping volunteers, maintenance and transport volunteers who continue to volunteer each week to provide support around our properties including transporting families to and from the Queensland Children's Hospital, beautifying our accommodation units and grounds.

Thank you to our Central Committee of Management, volunteers, Ambassadors, members, donors and fundraisers who continue to support this wonderful organisation.

A special thanks to my team for your unwavering support and care for our families. We are only a small team of 5 people, and your passion for our charity is commendable. Thank you, team.

We encourage the community, businesses and corporate organisations to get involved with Childhood Cancer Support and we look forward to your involvement in our redevelopment plan for our new East Brisbane Accommodation Village in the near future.

WELCOME TO OUR NEW FAMILY AMBASSADORS

Our story began in 2008 when our first-born daughter, Maggie (now 15) was diagnosed at 6 hours old. You can imagine the shock and devastation we went through. Forget being happy first-time parents. The uncertainty of what her life would be, the pain we would experience. We had a fight on our hands and then some.

Maggie and I were transferred down to the Royal Children's Hospital in Herston, and we met with our oncologist. The road would be rocky and long - we were given no guarantees, and our little girl's life was in the hands of professionals. Maggie went through gruelling chemo at two and half weeks of age. At four weeks Maggie was placed on life support as all her vital organs were shutting down. Good Friday loomed and we were expected to say goodbye - the doctors had done all they could. As we prepared to say our farewells, Maggie managed to have urine output which indicated her kidneys were starting to work. WOW what a roller coaster of a road - from darkness to having hope. We went through another round of chemo (half strength drugs) and as Maggie was then deemed in remission, we were advised the best chance was for an unrelated blood stem cell transplant (again risks were high). Maggie went back to ICU as her little body was fluid retentive, although this time we could put Maggie on dialysis. This time Maggie was again gravely ill and as she was hooked to various lines etc we were not able to cuddle her. This is not how parenting should be, not even in the slightest.

Maggie fought hard and won another fight (7 weeks in ICU - geez we were tired!). Maggie was now in remission and we spent seven and a half months as "guests" of the Children's Hospital.

We became involved with Childhood Cancer Support by going to the Friday night BBQs. Just having an outing for a few hours with like-minded people gave us some balance in this horrendous journey. By talking to people, it helped us know that we weren't alone. Sometimes, even though having some degree of family support, they just didn't understand how living and dealing with this just robs you of everything. Things you take for granted, little things.

We are still involved in Childhood Cancer Support by attending Camp Crystal, the Christmas Party, and EKKA Days. They bring us so much joy and we are extremely grateful to be a wonderful part of a group that are just awesome. Not only is Childhood Cancer Support there for the little one that is fighting the journey, but they also give support to us as a family. This is where John gets to relax (when he's not being a helicopter parent). Ruby can meet new and see "old" friends. Maggie gets to be Maggie, and I also get to relax a little and enjoy some time with other parents.

It's always hard finding words to say thank you. What Childhood Cancer Support do is above and beyond.

We are delighted to be the new West Moreton Family Ambassadors and wanting to support other families. We know the road is tough and there are many bumps, detours, and lots of hills to climb. If we can help families navigate this road, it will be our way of giving back.





MATILDA'S STORY

Hervey Bay family, Tammy and Michael were busy as could be with their two children and their third on the way. In what should have been an exciting time for this young family, Tammy went into labour five weeks early and after spending a week in hospital, Tammy was able to return home to celebrate her second daughter, Matilda's (Tilly) second Birthday. However, Tammy and Michael started to notice something different about their usual vibrant little girl.

Tilly is a busy little girl overflowing with life and sass. From the moment her eyes open in the morning Tilly is ready for adventure. Enjoying play group, walking down to the lagoon, feeding the resident ducks and going for walks on the esplanade with her bike. Growing into the social butterfly, Tilly's favourite activity was visiting her neighbours and jumping around on the trampoline.

Tilly's behaviour had suddenly changed; asking to be carried more, sweating while she slept, becoming pale and a sudden dislike towards one of her favourite pastimes, swimming.

In February, Tammy and Michael decided to take Tilly for what was planned to be a quick doctor's check-up. After one quick look at Tilly, the GP sent them straight to the emergency room for an immediate blood transfusion. Later that night, their worst fear became a reality as the doctors conveyed their concerns that Tilly had cancer. Immediately, Michael and Tilly were flown from Hervey Bay to Brisbane. Tammy drove down after them the following morning.

Just a short 24 hours later, on 9 February, Tilly was officially diagnosed with Leukaemia. A flurry of fears and questions began to torment Tammy and Michael as their new reality of blood transfusions and chemotherapy began to set in.

“Are we going to lose our child? Could we of prevented this or caught it earlier, and where do we stay with three children?”

The social worker quickly prepared accommodation arrangements for their family, however their 9-year-old would be unable to stay with them. Separated from each other, their family faced new struggles every day

with their newborn. The plan was not working, and Tammy and Michael needed another solution where they were able to stay together. Childhood Cancer Support stepped in and filled the gap for Tammy and Michael.

“Childhood Cancer Support has been so important to us. They have given us a beautiful home base with all the essentials we need - from a fully functioning kitchen to supplying clippers for when Tilly was sick of picking her hair out of stuff.”

Tilly's treatment has been a tough journey, but she has done a fantastic job hitting all her goals on the treatment path. However, it has not been without its share of hurdles.

“Without Childhood Cancer Support I'm not sure how we would have been able to get through the last six months. Thanks to Childhood Cancer Support we've been able to stay together as a family unit and live our life as normal as possible with routine and the comforts of home.”

It is my pleasure to work with such a great team here at Childhood Cancer Support. Supporting families during this emotional and traumatic time in their lives and giving them an inviting unit to call home is a priority. Each unit is kept updated, homely and inviting with the amazing help and support from our volunteers, who put their heart and soul into their work supporting our families. We are so grateful.

During the family's stay with us we will endeavor to support them with food (donated by OzHarvest and Community Canteen), patient transport services in our Van, "Stan the Van" to treating hospitals and airport runs when needed, as well as providing amazing services for families both emotionally and financially.

Our Learning Support Service, run by Lenore Irvine, allows patients and siblings to keep up with their schoolwork, if needed, giving them the confidence they need when returning home.

Our weekly Coffee, Cake and Chat events provide both children and parents a chance to relax, feeling supported by each other with their journeys and sharing of stories.

Children are able to have fun and run around our playground, make tea in our playhouse, ride our bikes, spend time on our swing, just time to be silly and have fun with other kids. It is a highlight for many families' week.

We were very excited that the Greenbank Services Club were able to grant us funding for our Music Therapy Program this year providing therapeutic healing for families. The families love the weekly sessions by our music therapist from Music Beat.

The Lord Mayor's Charitable Trust is a great support to our families, providing a grant to purchase Care Packs for our little patients, making their treatment a little more comfortable. They also arranged a visit from the Easter Bunny to our facilities this year.

Our families are very grateful for our Charity and all the support, guidance and nurturing we can offer them. I am so humbled and proud to be part of the team at Childhood Cancer Support and to be able to help families impacted by childhood cancer and, as a team, provide support and compassion to our families during this difficult journey.



PATIENT DIAGNOSIS



TIANA'S STORY

The Goodings family loved their life in Cairns. With their four children, the family loved to go camping, fishing, and enjoying the outdoors.

Their youngest daughter, 15-year-old Tiana is a happy and friendly girl, who loves dancing, friends and spending time with their two dogs, Toomba and Koda. Dancing had been a driving force in her life for over 11 years. She does ballet, contemporary, jazz, lyrical and hip-hop dancing and also teaches the younger kids.

When Tiana developed a sore groin, the family all thought it was due to the amount of dancing she did. Over 9 months, Tiana went to many physio and doctors appointments. Her symptoms worsened with her starting to feel fatigue after school. After months of appointments, Tiana finally went for an MRI scan.

Just 24 hours after the scan, the Daryl and Della were given the news that Tiana had a large tumour in her pelvis. Immediately, the family had to leave their home and travel to Brisbane for treatment. Further tests confirmed that Tiana had a Ewings Sarcoma. With the treatment impacting her fertility, the decision was made to postpone chemotherapy long enough for Tiana to go through IVF and freeze her eggs for possible future use.

After staying in temporary accommodation for the first few weeks, Tiana and her family moved into Childhood Cancer Support apartments at Herston.

“At first, we nearly couldn't believe it, it was just too good to be true but the very next day we were told that the bus was coming to pick us up and take us to our own three-bedroom house for as long as we need!”

There was a spare room, which meant that her brothers and sister could come and spend time with us, her grandparents could visit, her friends from Cairns could come and stay and catch up and we could "get away" from Hospital. It has made such a huge difference; we are so lucky.”

Tiana will need to go through 17 rounds of chemotherapy, which will take a minimum of 36 weeks. Having to leave the family, friends and the pets has been very challenging for the entire family.

“Childhood Cancer Support has made such a huge difference to my child and our family.”

“At a time when we are at our most vulnerable, having a house to live in together as a family has helped more than anything in the world. The staff and volunteers at Childhood Cancer Support work tirelessly to help change families lives by giving them the opportunity have some normality and concentrate on the important things in life whilst going through the toughest times of their lives far from home.”

YOUR GENEROSITY HELPS PATIENTS LIKE CHARLIE AND HER FAMILY

CHARLIE'S STORY

On Wednesday, 14 September 2022, Simone Lambert rushed her daughter Charlie to Townsville Emergency after discovering a slight bulge on her upper left stomach, with a stubborn second day high 40-degree temperature and sore stomach. Due to the late hour, the emergency staff decided their case not an emergency and admitted them to the Townsville Children's ward where they were able to steal a couple of hours sleep.

The following day, in a room full of health professionals, Simone was told the worst news a parent could hear.

"Your daughter has a mass tumour, but we don't know if it is cancer or not".

These words transformed their reality into a living nightmare. With each day away from home and sat in countless hospital chairs, Charlie and Simone learned to place more and more trust in the professionals around them. Taking each day at a time, Simone came to understand what questions to ask, and what she needed to know to best help her daughter.

After arriving in Brisbane, Charlie continued to need more tests which resulted in her becoming fearful of the nurses, hiding away in the cupboards when she saw them coming. Simone began to grow more and more frustrated and heartbroken to stand and watch from the sidelines, tirelessly trying to comfort Charlie.

After numerous tests, Charlie's doctor removed the tumour, weighing 1.4kg. A week later after the preliminary results,

it was declared that Charlie had a Stage 1 Wilms Tumour. What followed next was countless trips to the hospital and many treatments to help Charlie. Far away from their home in Townsville, Charlie and Simone moved into their new home at Childhood Cancer Support accommodation in Herston, Brisbane for the next six months.

Simone felt like the unit truly was a home away from home and walking into the space felt like a sigh of relief.

"Being a Friday when we moved in and no idea where any shops were, Childhood Cancer Support have a community room and fridges where Oz Harvest visit weekly and donated food is provided. A beautiful Welcome Pack tray was also provided and got us through with basics until we could go shopping."

Over the next few months, Charlie underwent two surgeries, 13 treatments of chemotherapy, a blood transfusion and countless number of other invasive tests. Childhood Cancer Support acted as the much-needed haven proving essential housing and emotional support, providing weekly coffee and cake events and monthly BBQs as an opportunity for staff and other families to get together and support each other.

Since arriving back home in Townsville, Charlie is still required to fly back to Brisbane every six weeks for scans and tests. Simone and Charlie have been able to access the short-term accommodation and transport services, which has helped make these frequent trips less of a burden.

"Nothing was ever too much trouble, as they gave so freely their time beyond the work of their role to support the children and their families."

TREASURER'S REPORT

Thank you to all who assist Childhood Cancer Support in delivering its much-needed services in 2023 - a 'home away from home' for so many suffering families.

From the wonderful Staff, Volunteers, Supporters, Fundraisers, my fellow Central Committee of Management members and the growing Childhood Cancer Support Community; Thank You it could not happen without you all.

2023 was much more a 'business as usual' year than previous years for Childhood Cancer Support, with a focus of course on our pending development in South Brisbane.

From a financial perspective 2023 FY was stable and measured. Overall income was \$60,000 or 3.4% below budget but controlled expenses only saw the organisation miss the bottom-line target by \$15,000.

Childhood Cancer Support saw a 10% shortfall from regular subsidies with our expected occupancy rate lower than budget. A meeting with hospital executives unfortunately confirmed there was no drop in paediatric oncology diagnosis, rather just a different mix of patients.

Third Party Fundraisers were the star in 2023 exceeding budget by 20% and raising \$380,000. The organisation greatly values the efforts of all involved with this wonderful outcome!

Grants Funding received were again significant with Helen and The Team doing a great job in achieving \$360,000 in income for the year – Well Done!

Total Assets remained at over \$10M with Total Equity slightly increasing and still over the \$7M mark.

The organisation maintained a strong Balance Sheet and met all statutory and operational requirements for the 2023 Financial Year.







Note 1: Summary of Significant Accounting Policies

Basis of Preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act of Queensland and where considered applicable that of the ACNC Act 2012. In the opinion of the committee the association is not a reporting entity because it is not reasonable to expect the existence of users who rely on the association's general purpose financial statements for information useful to them for making and evaluating decisions about the allocation of resources.

The financial report has been prepared in accordance with the Associations Incorporations Act of Queensland, the ACNC Act 2012 where considered applicable, the basis of accounting specified by Australian Accounting Standards and Interpretations where applicable, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors, AASB 1031: Materiality and AASB 1054: Australian Additional Disclosures.

The association has concluded that the requirements set out in AASB 10 and AASB 128 are not applicable as the initial assessment on its interests in other entities indicated that it does not have any subsidiaries, associates or joint ventures.

The association has not assessed whether these special purpose financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Accounts Receivables and Other Debtors

Accounts receivable and other debtors include amounts due from members where applicable as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(b) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

(c) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

(d) Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(f) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

The association has applied AASB 15: Revenue from Contracts with Customers (AASB 15) and AASB 1058: Income of Not-for-Profit Entities (AASB 1058) using the cumulative effective method of initially applying AASB 15 and AASB 1058 as an adjustment to the opening balance of equity at 1 July 2019. Therefore, the comparative information has not been restated and continues to be presented under AASB 118: Revenue and AASB 1004: Contributions.

In the current year**Contributed Assets**

In situations where the association receives assets from the government and other parties for nil or nominal consideration in order to further its objectives. These assets are recognised in accordance with the recognition requirements of other applicable accounting standards where considered applicable (eg. AASB 9, AASB 16, AASB 116 and AASB 138).

On initial recognition of an asset, the association recognises related amounts (being contributions by "related" parties, lease liability, financial instruments, provisions, revenue).

The association recognises income immediately in profit or loss as the difference between initial carrying amount of the asset and the related amount.

Operating Grants, Donations and Bequests

When the association receives operating grant revenue, donations or bequests, it assesses whether the contract is enforceable and has sufficiently specific performance obligations in accordance with AASB 15.

When both these conditions are satisfied, the association:

- identifies each performance obligation relating to the grant
-

- recognises a contract liability for its obligations under the agreement
- recognises revenue as it satisfies its performance obligations.

Where the contract is not enforceable or does not have sufficiently specific performance obligations, the association:

- recognises the asset received in accordance with the recognition requirements of other applicable accounting standards (eg. AASB 9, AASB 16, AASB 116 and AASB 138)
- recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer)
- recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

If a contract liability is recognised as a related amount above, the association recognises income in profit or loss when or as it satisfies its obligations under the contract.

Capital Grant

When the association receives a capital grant, it recognises a liability for the excess of the initial carrying amount of the financial asset received over any related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer) recognised under other Australian Accounting Standards.

The association recognises income in profit or loss when or as the association satisfies its obligations under the terms of the grant.

Interest Income

Interest revenue is recognised using the effective interest rate method.

Dividend Income

In situations where applicable the association recognises dividends in profit or loss only when the right to receive payment of the dividend is established.

Income from Sale of Goods

In situations where the association sells merchandise to the general public. Revenue is recognised when control of the products has transferred to the customer. For such transactions, this is when the products are delivered to the customers. Volume discounts could be provided with the sale of these items, depending on the volume of aggregate sales made to eligible customers over every six-month period. Revenue from these sales is based on the price stipulated in the contract, net of the estimated volume discounts. The volume discounts are estimated using historical experience and applying the expected value method. Revenue is then only recognised to the extent that there is a high probability that a significant reversal of revenue will not occur. Where there is expected volume discounts payable to the customers for sales made until the end of the reporting period, a contract liability is recognised.

A receivable will be recognised when the goods are delivered. The association's right to consideration is deemed unconditional at this time as only the passage of time is required before payment of that consideration is due. There is no significant financing component because sales (which include those with volume discounts) are made within a credit term of 30 to 45 days.

All revenue is stated net of the amount of goods and services tax (GST).

In the comparative period

Non-reciprocal grant revenue was recognised in profit or loss when the association obtained control of the grant and it was probable that the economic benefits gained from the grant would flow to the entity and the amount of the grant could be measured reliably.

If conditions were attached to the grant which must be satisfied before the association was eligible to receive the contribution, the recognition of the grant as revenue was deferred until those conditions were satisfied.

When grant revenue was received whereby the association incurred an obligation to deliver economic value directly back to the contributor, this was considered a reciprocal transaction and the grant revenue was recognised in the statement of financial position as a liability until the service had been delivered to the contributor; otherwise the grant was recognised as income on receipt.

Where the association received non-reciprocal contributions of assets from the government and other parties for no or nominal value.

These assets were recognised at fair value on the date of acquisition in the statement of financial position, with a corresponding amount of income recognised in the statement of profit or loss and other comprehensive income.

Donations and bequests were recognised as revenue when received.

Interest revenue was recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Dividend revenue was recognised when the right to receive a dividend had been established.

Rental income from operating leases was recognised on a straight-line basis over the term of the relevant leases.

Revenue from the rendering of a service was recognised upon the delivery of the service to the customer.

(g) Leases**The association as lessee**

Where considered appropriate by the associations management and members at the inception of a contract, the association assesses if the contract contains or is a lease. If there is a lease present, a right-of-use asset and a corresponding lease liability is recognised by the association where the association is a lessee. However, all contracts that are classified as short-term leases (lease with remaining lease term of 12 months or less) and leases of low value assets are recognised as an operating expense on a straight-line basis over the term of the lease.

Initially the lease liability is measured at the present value of the lease payments still to be paid at commencement date. The lease payments are discounted at the interest rate implicit in the lease. If this rate cannot be readily determined, the association uses the incremental borrowing rate.

Lease payments included in the measurement of the lease liability are as follows:

- fixed lease payments less any lease incentives
- variable lease payments that depend on an index or rate, initially measured using the index or rate at the commencement date
- the amount expected to be payable by the lessee under residual value guarantees
- the exercise price of purchase options, if the lessee is reasonably certain to exercise the options
- lease payments under extension options if lessee is reasonably certain to exercise the options and
- payments of penalties for terminating the lease, if the lease term reflects the exercise of an option to terminate the lease.

The right-of-use assets comprise the initial measurement of the corresponding lease liability as mentioned above, any lease payments made at or before the commencement date as well as any initial direct costs. The subsequent measurement of the right-of-use assets is at cost less accumulated depreciation and impairment losses.

Right-of-use assets are depreciated over the lease term or useful life of the underlying asset whichever is the shortest. Where a lease transfers ownership of the underlying asset or the cost of the right-of-use asset reflects that the association anticipates exercising a purchase option, the specific asset is depreciated over the useful life of the underlying asset.

Concessionary Leases

For leases that have significantly below-market terms and conditions principally to enable the association to further its objectives (commonly known as peppercorn/concessionary leases), the association has adopted the temporary relief under AASB 2018-8 and measures the right of use assets at cost on initial recognition.

(h) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

(i) Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.


